## Village Creek State Park Trails: Hike Report By Carmen Quinn

The Chapter's outing for March took place at Village Creek State Park near Wynne. It was a beautiful day for a hike - temperature just right, bright sunshine, good company. The weather had warmed up quite a bit from our bad weather earlier that week. The sign on the Visitor Center door at the park said all trails were closed due to snow and possible debris in the trail, but we got the OK from the Park staff to go ahead with our plans. There was significant snow still on the ground which added to the beauty of the scenery; unfortunately it also added a degree of difficulty to the hike.

We hiked on sections of different trails in the park, including the Austell Trail and the Lake Dunn Trail. This is actually a portion of the Trail of Tears. Called the "Memphis to Little Rock Road" it was completed in 1829 and provided the first improved route between Memphis and Little Rock. It was a major part of Indian

removal for Choctaw, Chickasaw and Muscogee (Creek). The route is part of the Trail of Tears National Historic Trail.

After walking across a rickety wooden bridge, the group stopped for lunch and planned two return routes to the trailhead. Due to extremely soggy trails and mud, a few of the hikers wanted to take a shorter trail back, and wait for the rest of the group at the Visitor's Center. It turned out the trail thereafter was so flooded and muddy that most of the group took the shorter route. But luckily the weather was warm enough that even wet feet were not too uncomfortable.

So we walked approximately 4 miles instead of 6; and many people, including me, rolled up soggy pant legs on the way home. But no complaints from this hiker. It was wonderful to be out in the woods after a year of recuperating. And any day in the woods is a good day.

**July 13 – 19: Colorado Trip.** The campground reservations have been made at the Cascade Campground in the Collegiate Peaks area of the San Isabel National Forest. The campground is located on County Road 162 west of Nathrop, Colorado. The trip is limited to 60 people so if you want to go you need to send in your reservation in by June 1, 2014

You should plan to arrive at the campground by mid-afternoon Sunday July 13. All meals will be provided through dinner on Friday July 18 as part of the trip. If you prefer motel accommodations to camping, you can make reservations at nearby Mount Princeton Hot Springs Lodge, 15870 County Road 162, Nathrop, Colorado, 719-395-2361. Meals at the campground will be provided for all trip participants, regardless of whether you are camping or staying at the lodge.

You must be an Ozark Society member to participate in this trip. You can join by sending \$15 annual dues along with your registration.
